**Transfer** of dogs from regular breed classes to BOB Competition (Ch. 11, Sec. 6 AKC Rules) **MUST** be made to the Show Secretary at least one-half hour prior to the start of any regular conformation judging at this show.

**Dogs need only be present for scheduled judging** and will be released if not needed for further judging.

**Judges are not required to wait for dogs.** The owner or handler of each dog is solely responsible for having it ready at ringside when its class is being judged.

**Exhibitors are responsible for clean up** in their grooming area and are responsible for their children at all times.

**The show hosts, the Show Secretary, and the Shetland Sheepdog Club of Georgia, Inc., their agents, directors, officers, members, etc. assume no responsibility** for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to their children.

**DIRECTIONS TO EMERGENCY VETERINARIAN:** From show site, turn right on Jonesboro Rd. (Hwy 54N). Cross over I-285 & turn left on ramp to I-285W. At I-285, exit 58 turn on ramp towards I-75/Atlanta/Macon. Merge onto SR-85. Go 13 miles to Fayetteville. Turn left at Banks Rd. Go approximately 1 to 2 miles to red light at Hwy 54. Turn right on Hwy 54. The clinic is about 1 block down on right side.
