Non-Regular Classes Involving Multiple Dog Entries

NR2.09100. *Stud Dog Class - For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes, or if a Champion of Record in Best of Breed Competition, but MUST be entered in the Stud Dog Class, the Get MUST be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee, this being the regular fee or the additional class fee if the Stud Dog is entered in another class. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

NR2.09200. *Brood Bitch Class - Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

*Chapter 11, Section 8 of the Dog Show Rules provide that "a castrated male may be entered as Stud Dog in the Stud Dog Class and a spayed bitch may be entered as Brood Bitch in the Brood Bitch Class".

Get Handlers shall wear their class armbands in the ring.

As the judge's decision in the Stud Dog and Brood Bitch Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed or Variety by virtue of having won these classes.

FUTURITY

Judge: Ms. Barbara Aulbach

Eligibility of all dogs entered in these stakes shall be subject to the following rules:

1. The Futurity Stakes are open to litters where the breeder of record is an ASSA member. Each ASSA member/member household may nominate only ten (10) owned or co-owned bitches per Futurity year. The bitch's nomination must be postmarked on the envelope before the litter is born. The Futurity is held on the day before the National and each puppy must be entered in a regular class at the National. Put "Futurity Class" and age division in the box on the entry form for "Additional Classes". There is no additional entry fee for the futurity class. **For questions only E-Mail address is: kyleneone@bellsouth.net**
2. All litters nominated for bitches that will whelp after the closing date of the prior Futurity and before the beginning 18 month date of the next Futurity will be added to the next Futurity by extending the 12 to 18 month class to include the date in the ineligible zone. If a bitch is due right on the borderline dates, you may keep her eligible in both Futurities by entering her in both and paying for both. Based on her actual whelping date she will then remain eligible in one or the other Futurity. Occasionally we have the opposite happen when Futurity year dates overlap. The same concept is applied - she may be nominated for both years and the puppies may be nominated for both Futurities also by paying double fees at each level. However, you must chose which Futurity you will show in. **You can only show a puppy in one Futurity.** If you decide to show the puppy in the 6 - 9 month class you may not show that puppy again in the 12 - 18 month class the following year.
3. Nominations of bitches bred may be made on the ASSA Bulletin Board forms, or a 3" x 5" card, if at all possible. If necessary, you may submit nominations on any piece of paper. You must include Show Location, Show date/year, Dam, Sire, Date bred, Breeder(s) and your complete address with phone number. Upon receipt of your bitch's nomination, a form will be mailed to you that will include your 3 month and 6 month reminders. This will be your only reminder. The fee of \$5.00 per dam must be enclosed with the original nomination and a fee of \$3.00 per puppy is due by 3 months with the exact whelping date and sex of each puppy kept nominated. A \$7.00 fee is due by six months for each puppy you wish to keep nominated, and you must include the pup's full AKC registered name, sex, and new owner (if any). Entries in the 6 to 9 months class must arrive at least 30 days prior to judging. Changes in the AKC name will be accepted upon receipt of copy of AKC refusal of proposed AKC name.
4. The Futurity will consist of six classes: 6 to 9 mos.; 9 to 12 mos.; 12 to 18 mos. Winners of all above classes will compete for Best in Futurity.
5. Fees received for each class, less 30% will be used as prize money in that class. Prize money will be divided as follows: 1st - 40%; 2nd - 30%; 3rd - 20%; 4th - 10%. Prizes revised if less than four (4) entries in a class. All prizes are paid to the handler in the ring. The 30% of Futurity money held out is for Futurity expenses (20%) and for special awards (5%). Special award of 5% of the total prize money will be paid, for each Futurity, to the ASSA member breeder of the Best in Futurity winner.
6. **All nominations, correspondence and checks (payable to ASSA Futurity) are to be sent to the Chairperson, Dianne Hawes, 2404 Ridgeford Ct., Fuquay Varina, NC 27526-9000, phone (919) 552-6543, E-mail: wistwin@yahoo.com**
7. All money paid in is irrevocable with these exceptions: Overpayment made in error, nominations arriving too early or too late for age of classes. Money is not returned for "misses". Members recruited to judge these shows will have their money returned on request. Request must be made thirty (30) days before the date of the Futurity for a refund.
8. On checks for the original nomination of the bitch, please write the bitch's AKC name. On 3 and 6 month nominations please write the Futurity litter number assigned.

9. Please do not send Certified Mail or Air Express letters. Remember, eligibility is determined by the postmark, not delivery date (except for the Futurity closing date of 1 month prior to judging.)
10. Canadian members, please send your Futurity fee by Postal Money Order/US funds.
11. Whenever there is a NSF check, the nomination for a litter will be ineligible until the check is made good and all bank charges incurred by ASSA are reimbursed.
12. If you wish to know that your 3 month and 6 month Futurity nomination has safely arrived, please include a self-addressed, stamped postcard or letter with your return nomination. The first nomination is acknowledged by the sheet returned to you with the tear off sections for the continuing 3 and 6 month nominations. If you do not get this back, I never received the original one.

NOVICE JUNIOR CLASS: For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE CLASS: For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS: For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS: For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN INTERMEDIATE CLASS: For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN SENIOR CLASS: For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

Each dog entered in a regular Junior Showmanship Class must be of a breed eligible to compete in the conformation classes (including Miscellaneous Classes) at the event. Dogs may be ILP, Full or Limited-Registered to compete in Junior Showmanship Classes, additionally, spayed and neutered specimens are eligible for competition. Breeds excluded from competition at the event are not eligible. The dog must be entered in one of the classes associated with the event or must be entered for Junior Showmanship only. An eligible dog other than the one entered may be substituted. Such substitutions must be accompanied by an official AKC entry form. The junior must have the AKC number of the substitute dog. All such substitutions must be made with the Superintendent or Show Secretary at least one half hour prior to the judging of any Junior Showmanship Classes at the show. Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncles, aunt, grandfather, or grandmother, including the corresponding step and half relations, or by a permanent member of the Junior Handler's household as recorded with the American Kennel Club at the time entries close or an application for transfer of ownership must be sent to The American Kennel Club by the new owner within seven days after the last day of the show. BITCHES IN SEASON ARE NOT ELIGIBLE. At a Specialty Show, each dog must be of the breed for which the show is held. A junior is limited to one substitution at a dog show. If one of the owners of the dog is a judge, the dog may be entered in Junior Showmanship Only to be exhibited by the Junior at an event where the judge is judging classes other than Junior Showmanship.

A dog that has been rejected, dismissed or excused by the veterinarian for the protection of the other dogs at the show or for the protection of the dog excused, may not be handled in Junior Showmanship. Entries for Regular Junior Showmanship Classes shall close at the same time that entries close for this show.

Winning First Place in an Open Junior Showmanship Class at this show may qualify, or count toward qualification for entry in certain future limited Junior Showmanship Classes. For information on the eligibility requirements for Limited Junior Showmanship Classes which have been approved to date by AKC, write to AKC, Event Plans, P.O. Box 900051, Raleigh, NC 27675-9051.

Dogs who make a cut or earn placements and awards in breed competition will be awarded 2, 3, or 4 points as applicable to the award, but do not receive the participation point as well. Dogs who make multiple cuts in class will receive the same two points as dogs who make one cut. Dogs excused from the breed ring shall still be awarded a point for participation. Dogs disqualified from the breed ring shall not be awarded a point for participation.

In the event of a tie, event scores shall be used to break the tie. The dog with the highest total score will receive the award.

The official catalog markings taken from the judges' books for each event shall be used to determine eligibility, participation, placements and official scores.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
